**FOOD SAFETY ACT
(CAP. 449)**

Foods intended for use in Energy-Restricted Diets for Weight Reduction (Amendment) Regulations, 2007

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister of Health, the Elderly and Community Care has made the following regulations:-

Citation.
L.N. 1 of 1999.

1. The title of these regulations is Foods intended for use in Energy-Restricted Diets for Weight Reduction (Amendment) Regulations, 2007, and they shall be read and construed as one with Foods intended for use in Energy-Restricted Diets for Weight Reduction Regulations, 1999, hereinafter referred to as “the principal regulations”.

Scope.

2. These regulations implement the provisions of Commission Directive 2007/29/EC of 30th May, 2007.

Amends regulation 6.3 of the principal regulations.

3. Regulation 6.3 of the principal regulations shall be substituted by the following:

“6.3 The labelling, advertising and presentation of the products concerned shall not make any reference to the rate or amount of weight loss which may result from their use”.
