**FOOD SAFETY ACT  
(CAP. 449)**

**Sweeteners for Use in Foodstuffs (Amendment) Regulations, 2005**

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister of Health, the Elderly and Community Care has made the following regulations:

Citation.

**1.** The title of these regulations is the Sweeteners for Use in Foodstuffs (Amendment) Regulations, 2005, and they shall be read and construed as one with the sweeteners for Use In Foodstuffs Regulations, 2005, hereinafter referred to as “the principal regulations”.

L.N. 30 of 2005.

Amends regulation 1 of the principal regulations.

**2.** For regulation 1.3(b) of the principal regulations there shall be substituted the following:–

“1.3(b) Commission Directive 95/31/EC laying down specific criteria of purity concerning sweeteners for use in foodstuffs, as amended by Directives 98/66/EC, 2000/51/EC, 2001/52/EC and 2004/46/EC”.
