Titolu.

2. Dawn ir-regolamenti jimplimentaw il-provvedimenti tad-Direttiva tal-Kummissjoni 2006/142/KE tat-22 ta' Dicembru, 2006. Mit-23 ta' Dicembru, 2008, bejgh ta' ikel li ma jkunx skond din id-Direttiva ghandu jkun ipprojbit. Madankollu, bejgh ta' ikel li ma jkunx skond din id-Direttiva u li jkun lest bit-tikketta qabel din id-data ghandu jiġi awtorizzat sakemm jispicċa l-istokk.

**FOOD SAFETY ACT
(CAP. 449)**

**Labelling, Presentation and Advertising of Foodstuffs
(Amendment) (No. 3) Regulations, 2007**

IN exercise of the powers conferred by article 10 of the Food Safety Act, the Minister of Health, the Elderly and Community Care has made the following regulations:–

Citation.

1. The title of these regulations is the Labelling, Presentation and Advertising of Foodstuffs (Amendment) (No. 3) Regulations, 2007, and they shall be read and construed as one with the Labelling, Presentation and Advertising of Foodstuffs Regulations, 2004, hereinafter referred to as “the principal regulations”.

Scope and commencement.

2. These regulations implement the provisions of Commission Directive 2006/142/EC of 22nd December, 2006. As from 23rd December, 2008, the sale of foodstuffs which fail to comply with this Directive shall be prohibited. However, the sale of foodstuffs which fail to comply with this Directive and which have been labelled prior to this date shall be authorised until stocks run out.

Amends the Third Schedule to the principal regulations.

3. For Part B of the Third Schedule to the principal regulations, the following shall be added:

‘Lupin and products thereof

Molluscs and products thereof’.
